Dan huwa I-ewwel rapport tal-Malta Community Chest Fund Foundation (MCCFF) taħt din il-Presidenza. L-E.T. Dr George Vella, ħa I-ġurament bħala I-Kap tal-Istat ta' Malta fl-4 ta' April 2019.

F'dan ir-rigward, nixtieq nieħu l-opportunità biex nirringrazzja lill-President Emeritu Marie Louise Coleiro Preca li l-MCCFF kienet taħt il-patroċinju tagħha sat-3 ta' April 2019.

Jiena ngħaqadt mat-tim ta' voluntiera fuq stedina tal-E.T. il-President f'Ġunju 2019 bħala ċ-Chairperson tal-Bord tal-Amministraturi. Kien vjaġġ mill-isbaħ fejn għalkemm tiltaqa' ma' stejjer ta' qsim il-qalb, hemm ukoll is-sodisfazzjon li tara stejjer ta' suċċess ta' fejqan u rkupru.

Fil-missjoni tagħha, il-MCCFF tosserva governanza assoluta, u tibbaża l-ħidma tagħha fuq tliet prinċipji prinċipali: trasparenza, kontabilità u ġustizzja. Il-Fondazzjoni tiddependi esklussivament minn donazzjonijiet mill-membri tas-soċjetà, individwi u kumpaniji, kif ukoll għajnuna finanzjarja mill-Gvern meta dan ikun meħtieġ. Il-fondi jinġabru wkoll minn attivitajiet organizzati ta' ġbir ta' fondi, fosthom il-Ballu tal-Qamar ta' Awwissu, il-Fun Run, Rockestra u I-Istrina. Sfortunatament, il-Fun Run li kellha ssir f'Ottubru 2019, kellha titħassar minħabba I-maltemp.

Aħna għandna l-obbligu li niżguraw li kull ċenteżmu, mhux talli nagħtu rendikont tiegħu bl-aktar mod trasparenti, talli nużawh biex ngħinu lil dawk l-aktar vulnerabbli fis-soċjetà tagħna. Ġew introdotti linji gwida biex niżguraw tgħarbil diliġenti u ġust tal-applikanti. Permezz tal-means testing niżguraw ukoll li jiġi osservat il-prinċipju ta' ġustizzja billi ngħinu biss lill-individwi li tassew għandhom bżonn. It-talba għal għajnuna finanzjarja, b'mod partikolari għat-trattament u I-mediċini għall-kanċer, żdiedet b'mod progressiv minn €8.5m fl-2018 għal €13.2m fl-2019. II-firxa ta' individwi tas-soċjetà li jfittxu I-għajnuna tal-Fondazzjoni hija wiesgħa u varjata. II-MCCFF tistinka biex tgħin lil kemm jista' jkun persuni, iżda I-isfida finanzjarja hija waħda kostanti.

L-għajnuna finanzjarja ma tkoprix biss individwi li jbatu b'diversi mard serju u li jaffaċċjaw spejjeż enormi ta' trattament, kemm f'Malta kif ukoll barra minn Malta; iżda tkopri wkoll lil familji li jinsabu taħt il-linja tal-faqar billi niffinanzjaw ħtiġijiet bażiċi u *food vouchers* sabiex ikunu jistgħu jgħixu ħajja dinjituża; lil persuni li jakkumpanjaw lil qraba, normalment tfal, li jkunu jeħtieġu trattament barra minn Malta, kif ukoll lil persuni li jkunu għaddejjin minn kimoterapija u jkunu jeħtieġu parrokki bħala konsegwenza tat-trattament, u għajnuna oħra skont il-bżonn.

Nixtieq nikkonkludi billi nirringrazzja lill-E.T. il-President, Dr George Vella u lis-Sinjura Miriam Vella, li l-enerģija u d-dedikazzjoni tagħhom lejn membri vulnerabbli tas-soċjetà tagħna, huma ta' ispirazzjoni għalina lkoll. Nixtieq nirringrazzja wkoll lill-membri tal-Bord tal-Amministraturi, lill-membri tal-Kunsill Superviżorju, lill-impjegati u l-voluntiera tal-MCCFF, u b'mod speċjali lill-membri tal-Unità tal-Għajnuna Medika, tal-Unità tal-Għajnuna Soċjali. Fuq kollox nirringrazzja lill-pubbliku inġenerali u sponsors li l-ġenerożità tagħhom tagħmilha possibbli biex aħna nkunu nistgħu nagħmlu differenza lil dawk li jiġu għandna għall-għajnuna.

Fl-2018 il-kondizzjoni tas-saħħa tagħha marret għall-agħar u ntbagħtet Londra għal trapjant tal-fwied. Damet kważi sentejn tistenna sakemm instab fwied li jaqbel magħha. Christine ġiet operata u l-fwied il-ġdid ġie ttrapjantat f'Ĝunju li għadda.

Fiż-żmien li għamlet barra minn Malta, aktar minn 24 xahar, Christine kienet akkumpanjata mis-sieħeb tagħha u l-Malta Community Chest Fund għenithom matul dan iż-żmien kollu billi ħallset it-titjiriet, l-akkomodazzjoni, l-ikliet u spejjeż ta' kuljum.



MARIA MARIELLA ATTARD

Maria Mariella ilha għaddejja minn kimoterapija speċjalizzata għal dawn I-aħħar erba' snin u nofs wara li ġiet iddijanjostikata b'kanċer tas-sider. Boċċa żgħira li ħasset, bidlitilha ħajjitha kompletament u beda vjaġġ iebes ta' testijiet, appuntamenti I-isptar, kimoterapija u I-effetti tagħha.

II-kimoterapija mhix trattament faċli, iżda hija essenzjali biex tiġi miġġielda I-marda fiha, għalhekk Maria Mariella kienet taf li din kienet I-unika għażla tagħha. II-kimoterapija ta' Maria Mariella tammonta għal €5,600 fix-xahar u kieku ma sabitx I-għajnuna tal-Malta Community Chest Fund ma kienx jirnexxilha tħallas għat-trattament tagħha. S'issa, hija ngħatat għajnuna ta' €200,300.



KENDRA ATTARD

Kendra hija tifla ta' 5 snin mimlija ħajja u ferħ. Tliet snin ilu, vista normali għal uġigħ fil-griżmejn wasslet f'inkubu għal ommha Joelene, hekk kif Kendra ġiet iddijanjostikata b'retinoblastoma akuta u f'inqas minn 48 siegħa kellha tiġri lejn Londra fejn ommha ġiet informata li sabiex Kendra tkompli tgħix, għajnha kellha titneħħa għalkollox, inkella I-possibbiltà li I-kanċer jinfirex kienet ser tkun kbira wisq.

B'qalb imtaqqla, ommha kellha tiffirma l-permess biex titneħħa għajn bintha. Minn dakinhar, Kendra marret Londra diversi drabi għal visti ta' wara l-operazzjoni. Minkejja dak kollu li għaddiet minnu, hija tgħix ħajja normali mdawra bil-familja u l-ħbieb tagħha.

The role of the Supervisory Council is to monitor and supervise the activities of the Foundation to ensure that these are carried out in accordance with the Foundation's Statute. In addition, it ensures that the Foundation establishes policies and systems of communication and accounting which ensure proper transfer of information to the Supervisory Council and generally suitable transparency at all times relating to its activities, receipts and expenditure, selection of employees, and day to day operations.

The responsibilities of the Board of Administrators is to report regularly in suitable detail to the Supervisory Council on all matters relating to the activities of the Foundation, which are material. This Board seeks guidance from the Supervisory Council to establish consensus on the integrity and transparency of the processes and methodologies adopted by the Foundation.

PURPOSES AND OBJECTS OF THE FOUNDATION

The purpose of the Foundation is to provide financial, material and professional support in Malta and Gozo to:

- (i) individuals;
- (ii) families and communities;
- (iii) voluntary organisations which are enrolled with the Commissioner of Voluntary Organisations; and
- (iv) other organisations which satisfy all the criteria as set out by the Foundation from time to time.

This support is provided with the aim of improving the quality of life and care of individuals and society in general, and this without any form of discrimination on the basis of social class, gender identity, ethnicity, age, ability, health, status or religion, in the case of individuals and families, and size, membership or public benefit purposes, in the case of organisations.

The Foundation may provide the support described even overseas when necessary and appropriate.

The purposes and/or objectives of the Foundation shall be achieved by ensuring the effective and transparent application of disbursement of funds raised through fund raising activities, donations, contributions, bequests, endowments and legacies or otherwise, and include the following:

- to enhance the support and contributions from any source or sector of Maltese society to social justice, democracy and sustainable development in Malta;
- (ii) to strengthen solidarity through civil society development;
- (iii) to enable solidarity and social enterprise;
- (iv) to advance the education and dignity of underprivileged children, particularly those who, are or have been, in care systems;
- (v) to promote international collaboration in research and aid in conformity with the purposes and objects of the Foundation; and
- (vi) to carry out such activities as may be ancillary to the above as may be necessary or desirable to achieve the above purposes and objects.

The Foundation shall support organisations which have similar purposes and objects to those of the Foundation as outlined above in serving individuals, families and communities in need.

THE BOARD OF ADMINISTRATORS' REPORT

FOR THE YEAR ENDED 31 DECEMBER 2019

The Board of Administrators presents its report of The Malta Community Chest Fund Foundation (the "Foundation") for the year ended 31 December 2019.

PRINCIPAL ACTIVITIES

The Foundation is a philanthropic organisation regulated by the Civil Code under the auspices of the President of Malta with the principal aims as set out in Purposes and Objects of the Foundation section of this Report.

REVIEW OF ACTIVITIES FOR THE YEAR

During the year under review, the Foundation reported a surplus of €851,682.

Total contributions for the year amounted to €6,489,526 whilst reimbursement from Government, for oncology medication, amounted to €11,044,313. As at 31 December 2019, total assets exceeded total liabilities by €1,838,296.

RESPONSIBILITIES OF THE ADMINISTRATORS

The administration and management of the Foundation is vested in the Board of Administrators, who shall manage the Foundation in accordance with the purposes and objects of the Foundation, and subject to the terms of its Statute and applicable law.

The Board of Administrators shall be responsible for the executive management of the Foundation, and shall be responsible for the execution and implementation of the decisions taken by itself and the Supervisory Council.

The duties of the members of the Board of Administrators shall *inter alia* include the proper keeping of books of accounts, record all income and expenditure of the Foundation and other records which properly and fully reflect the operations and transactions of the Foundation.

In terms of the above-mentioned duties, the Foundation publishes a summary of the financial statements namely Income Statement and Balance Sheet, which are in representation of its operations and transactions, a clear financial communication of both collections and assistance distributed in line with the Foundations transparency intentions.

BOARD MEMBERS

The members of the Board of Administrators who held office during the year are set out in the Governance of the Foundation section of this Report. The Chairperson of the Supervisory Council appoints the members of the Board of Administrators from time to time.

AUDITORS

A decision to re-appoint KPMG as auditors of the Foundation will be proposed at the forthcoming Board of Administrators meeting.

MESSAGE FROM H.E. PRESIDENT OF MALTA

The Malta Community Chest Fund and the Presidency of our country have now become synonymous. This institution that helps so many people who are unfortunately affected by either illness or misfortune in life, has grown so much that it has its own identity, its own leadership, and its own challenges.

Since I was sworn in as President, I have done my utmost to ensure that the change of Presidency does not affect the work of this charitable institution. I felt it was wise not to change any of the individuals, who voluntarily and with so much dedication made a significant contribution through the Supervisory Council, the Board of Administrators, and the specific committees that receive, screen and approve assistance applications.

I set my sights on making sure that the traditionally held big fund-raising events, including the August Moon Ball, the Fun Run, Rockestra, and eventually L-Istrina, are a success.

In this regard, I want to give my heartfelt thanks to all those involved, sometimes working under pressure and in trying circumstances.

I felt that there was a need for some control over who qualified for certain benefits and this was done by starting to apply '*means testing*' as is also done in government housing applications.

I have to say that the biggest worry was the rising cost of anti-cancer medicine. Prices have gone up and unfortunately the number of patients has increased as well.

I always believed that this is a sector that should ultimately be managed by the health authorities, but so far, despite discussions I have had with all interested parties, we have not yet found a way of how this can be done. Over the months it has been very gratifying to get to personally know those who have traditionally been the big financial contributors of the Malta Community Chest Fund.

I sincerely thank them on behalf of the people of Malta and Gozo.

It was just as nice to meet those thousands of 'small' donors who send out donations over the months or give you a donation wherever they meet you.

As a doctor and father, I cannot help but mention the heartache one feels each time when dealing with a new case of illness, especially in young patients.

My wife Miriam and I experienced this, particularly when visiting Maltese patients in England, and we understood better the hardships they face when being referred abroad for more specialised care.

I want to give special thanks to all those who help in such cases. A big thank you goes to all the volunteers who over the years give some of their time to help those less fortunate. I would also like to thank Mrs Marlene Mizzi who voluntarily assumed the role of Chair of the Board of Administrators of the Malta Community Chest Fund Foundation, and gives a lot of her time to ensure that this institution continues to move forward. I would also like to thank all the staff of my Office who in their daily work make no distinction between the work of the Presidency and that of the Malta Community Chest Fund and to all the staff of the Foundation for their work.

Lastly, I promise that both my wife Miriam and I will continue to consider the functioning of the Malta Community Chest Fund as an important mission and a full part of the Presidency, and we promise to continue to address all the needs for it to remain a shelter and a beacon of hope to anyone who needs the services it offers.

CHAIRPERSON'S STATEMENT

This is the first report of the Malta Community Chest Fund Foundation (MCCFF) under the current presidency. H.E. Dr George Vella was sworn in as Malta's Head of State on 4th April 2019.

In this regard, I would like to take the opportunity to thank the President Emeritus Marie Louise Celerio Preca who was the patron of the MCCFF until 3rd April 2019.

I joined the team of volunteers on the invitation of H.E. the President in June 2019 as the Chair of the Board of Administrators. It has been a wonderful and fulfilling journey, encountering heart-breaking stories, but also experiencing the satisfaction of witnessing success stories of healing and recovery.

The MCCFF keenly observes proper governance in its mission, and basis its operation on three major principles: transparency, accountability, and justice. The Foundation is exclusively dependent on donations by members of our society, individuals, and companies, as well as financial assistance by the government when this is necessary. Funds are also raised through organised fund-raising activities, including the Ball of the August Moon, the Fun Run, Rockestra and L-Istrina. Unfortunately, the Fun Run, which was meant to be held in October 2019, had to be cancelled due to inclement weather.

We are obliged to ensure that each cent is not only accounted for in the most transparent manner but is used to help the most vulnerable of our society. A set of guidelines have been introduced to ensure diligent and fair vetting of applicants. Through *means testing*, it is also ensured that the principles of fairness and justice are observed by assisting only genuinely deserving individuals. The request for financial assistance, particularly for cancer treatment and medication has spiralled from $\in 8.5$ m in 2018 to $\in 13.2$ m in 2019. The spectrum of society which embraces those who turn to the Foundation for help is wide and varied. The MCCFF endeavours to assist as many as is possible, but the financial challenge is consistently daunting.

Financial assistance does not only cover individuals suffering from a variety of serious illnesses and who face exorbitant cost of treatment, both in Malta and abroad; but also covers families living below the poverty line by financing basic needs and *food vouchers* in order for them to lead a dignified life; to persons who accompany relatives, usually children, needing treatment abroad, as well as to persons undergoing chemotherapy and who need wigs as a consequence of the treatment, and other assistance as the need arises.

I would like to conclude by thanking H.E. Dr George Vella, President of Malta and the Mrs Miriam Vella, whose energy and dedication towards vulnerable members of our society, is an inspiration to us all. Thanks, are also due to the members of the Board of Administrators, the members of the Supervisory Council, MCCFF staff and volunteers, especially the members of the Medical Assistance Unit and the Social Assistance Unit. Above all, I would like to thank the general public and sponsors whose generosity make it possible for us to make a difference to those who turn to us for help.

Christine had been struggling with liver problems for these past 21 years. In 2016 Maltese Doctors sent her for further investigations to London where she was diagnosed with Budd-Chiari syndrome.

In 2018 her health condition deteriorated and was sent to London for a liver transplant. The wait for the right liver match took almost 2 years. Christine was operated and the new liver transplanted last June.

During Christine's stay abroad for over 24 months she was accompanied by her partner and the Malta Community Chest Fund was there for them throughout paying his flights, accommodation, meals and everyday expenses.



MARIA MARIELLA ATTARD

Maria Mariella has for these past four and half years been on a specialized chemotherapy after she was diagnosed with breast cancer. A tiny lump she felt changed her life drastically and a hard road of tests, hospital appointments, chemotherapy and it's effects started.

Chemotherapy is not an easy ride, but essential to fight the disease within so Mariella knew it was her only option. The chemotherapy Maria Mariella takes costs €5,600 each month and had she not found the Malta Community Chest Fund's help she would not have managed to pay for her treatment. To date she has been assisted with a total of €200,300.



KENDRA ATTARD

Kendra is a 5 year old girl full of life and happiness. Three years ago, a routine check up for a sore throat resulted into a nightmare for her mother Joelene where Kendra was diagnosed with acute retinoblastoma and in less than 48 hours she had to be rushed to London where her mother was informed that in order for Kendra to live, her eye had to be completely removed otherwise the chance of the cancer spreading was too high.

With a heavy heart her mother had to sign the permission to have her daughter's eye removed. Since then, Kendra has travelled numerous times to London for post operation check-ups. In spite of what she went through she leads a normal life surrounded by her family and friends.

Kendra has two other siblings, so for her mother to travel abroad with her and to leave her other children behind was also a great challenge, apart from the financial burdens they had to go through. Joelene insists that had it not been the Malta Community Chest Fund who assisted them each time they had to travel they definitely would not have managed.
